- e. Driving without being licensed to drive, except where the driver's or commercial driver's license had been expired for six months or less
- f. Reckless operation
- g. A third (or more) moving traffic offense within a twelve (12) month period
- h. Failing to stop for a school bus
- i. Willfully eluding or fleeing a police officer
- j. Drag racing
- k. Any offense not otherwise listed that is charged as other than a minor misdemeanor
- I. Handicapped Parking
